Are there minimum or maximum requirements for how many institutions should be included in the consortium? Does one institution from this consortium do the application procedure on behalf of others?Thanks, Zarina Burkadze, ISU.

What is a priority this year, I mean is it one of the exact directions?

Can you provide information about calls that do not require a large consortium. For example 3-4 participants with a total budget of 200 000-400 000 Euros?

How are projects evaluated (by what criteria) and what sectors are mainly funded? Is it necessary for the project to be of an applied nature, ie is theoretical research funded?

Who can participate in Horizon Europe? May Young scientists take part as well?

is it possible the consortium includes only Georgian universities and researchers?

So It will be better to be the organisation which starts the project, but it is quite hard for Georgian Universities, because we lack experience, how can we improve our reputation?

How to join a large consortium of an important project if it is not registered in the partner search system? What other mechanisms can we use?

Could you please tell, when the TRL is needed for the particular call? Who are evaluating the technology level? Is there any certification needed? Thank you

Answer: An assessment of the TRL is formally required only if it is mentioned in a call. If so, it may be needed several times because it may (or should) change during the course of the project. The evaluation happens in the framework of the project proposal evaluation or of the project monitoring by international experts. A TRL may also be used on a voluntary basis if this is suitable regarding the project subject. There is no external certification needed, unless mentioned.

There are cases when an article sent for publication is returned and when the author publishes his work in another journal, scientific papers based on identical ideas appear in parallel. In such a case, there is a clear suspicion of the unscrupulousness of the reviewers. So, if there is any mechanism that ensures the protection of the ideas presented in the proposal?

Answer: Yes, reviewers have stolen ideas before, I know of such cases, but not within the framework programme, but of course it may happen anytime. There is no formal mechanism established to prevent such issues, if needed it could only be followed up on a case-by-case basis.
